4. Custom passed proper endorsed
5. Shipping documents

2. Original Certificate of Origin/GSP
Copy of shipping bill
3. Original Exp copy

Docs required by overseas (Pre-Alert)

1. Copy MBL/HBL
2. Invoice & Packing List (Optional)
3. ZT Invoice
4. Certificate of Origin/GSP (Optional)

1. MAWB, HAWB & Manifest
2. Invoice & Packing List
3. Certificate of Origin
4. GSP (If applicable)
5. Debit note & Profit share
